17 ORDER GRANTING MOTION FOR ATTORNEYS' FEES AND COSTS

18 The Court has read and considered the legal memoranda and exhibits submitted in support of
19 and in opposition to Defendant Nevada Security Bank's *Motion for Attorney Fees and Costs*, filed
20 March 17, 2006 and submitted April 11, 2006. According to NRS 18.010(2)(b), the district courts
21 have discretion to award attorney's fees to a prevailing party "in all appropriate situations." The
22 Plaintiffs failed to abide by this Court's orders and refused to cooperate with the Defendants in
23 litigating this case. Therefore, the Court finds an award of attorney's fees is justified. Accordingly,
24 Defendant Nevada Security Bank's *Motion for Attorney Fees and Costs* is GRANTED. The
25 Defendant is awarded \$1,498.37 in costs and \$61,392.50 in attorneys' fees.


