All rights, title, and interest in and to 1.12 acre-feet annually at a diversion rate of 0.0015 c.f.s., being a portion of Permit 60638, (Well #4) being the subject of Application 74300 on file at the State of Nevada, Division of Water Resources.

These water rights are being conveyed to provide dedicated water rights to Douglas County on behalf of John and Pamela Jackson, to satisfy a condition under the approval of Parcel Map for John and Pamela Jackson, LDA #05-091 by Douglas County.
