(\$19.93) incurring if any payment was more then ten (10) days late. The second promissory note, dated April 10, 2004, had a face value of One Hundred Thousand and No/100 Dollars (\$100,000.00) with interest at Seven Percent (7%) per annum and required monthly payments on the fifteenth of each month, with a late fee of Seventy and No/100 Dollars (\$70.00) incurring if any payment was more then ten (10) days late. 
