

AMENDED DECLARATION OF THE ROBERT AND BETTY COLBURN REVOCABLE LIVING TRUST dated August 21, 1997 And AMENDED DECEMBER 28, 2004

This "Amended Declaration of the Robert and Betty Colburn Revocable Living Trust dated August 21, 1997 and December 28, 2004", dated October 11, 2006, amends Article Two, Section C, 'Distributions to Trust Estate Upon the Settlors' Deaths:', Paragraph (2), 'Distributions of Income and Principal:' of the "Robert and Betty Colburn Revocable Living trust dated August 21, 1997 and December 28, 2004 and is by and between Robert Colburn and Betty Colburn, as husband and wife, individuals hereinafter referred to as the settlors, of Douglas County, Nevada, and Robert Colburn and Betty Colburn, husband and wife, Hereinafter referred to as the Trustee or Trustees.

It is the intention and direction of the Settlors to amend said Trust in accordance with their authority as Settlors of this revocable Trust under Article Five, Section C of said Trust, as follows: The entirety of Article Two, Section C, Paragraph (2) of the Declaration of the Robert and Betty Colburn Revocable Living Trust dated August 21, 1997 and December 28, 2004 is hereby deleted and replaced with the following:

- (2) Distribution of Income and Principal: Upon the death of both Settlors, the then remaining Trust Estate shall be distributed as follows:

 - (E) To Frances Kim Liptak Quesada, if then living, the sum of Twenty Thousand Dollars, or two and one-half percent (2.5%) of the Trust Estate, which ever is less.
