7-1| Bodice MODIFICATION AGREEMENT TO HOME EQUITY LINE OF CREDIT AGREEMENT AND

This Modification Agreement (this "Modification") is made as of 8/1/2006, between GARY JOHNSTON (the "Borrower(s)") and Countrywide Home Loans, Inc.. 
