ASSIGNMENT OF RENTS

THIS ASSIGNMENT OF RENTS dated October 27, 2006, is made and executed between CTH Minden, LLC, a Nevada limited liability company, whose address is 160 West Huffaker Lane, Reno, NV 89511 (referred to below as "Grantor") and Pacific Western Bank, whose address is 401 West "A" Street, San Diego, CA 92101 (referred to below as "Lender").


