STIPULATION FOR ENTRY OF JUDGMENT

IT IS HEREBY STIPULATED AND AGREED by and between CERTAINTEED CORPORATION, ("Plaintiff"), and ROBERT DALLAIRES, as an individual and NEVADA FENCE, a Nevada Partnership, ("Defendant(s)"), that Judgment be entered in favor of the Plaintiff and against the Defendant(s) for the amount of \$10,242.62, plus accrued interest on the principal balance in the amount of \$1,254.41 through June 26, 2006, along with Plaintiff's costs of suit in the amount of \$561.00, and Plaintiff's attorney's fees in the amount of \$350.00, and together with interest on the principal balance at the statutory rate per annum from June 26, 2006 until this debt is paid in full.

The Defendant admits that he/she has no defenses or setoffs in this case.

It is further stipulated and agreed that this Judgment shall be paid as follows:

1. Payments shall be made in an amount of no less than \$500.00 per month by the 15TH day of every month, with the first payment being due on or before JULY 15, 2006.
2. That the Plaintiff agreed to forgive accrued interest in the amount of \$3,000.00



3 no grace period.

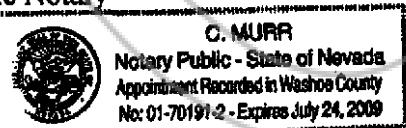
4 4. It is further understood by the Defendant(s) that if the Plaintiff has not received
5 payment as previously stipulated, the terms of this agreement will no longer be in effect.
6 Therefore, that Judgment be entered in favor of the Plaintiff and against the Defendant(s) for the
7 amount of \$10,242.62, plus accrued interest on the principal balance in the amount of \$1,254.41
8 through June 26, 2006, plus additional accrued interest in the amount of \$3,000.00 which the
9 Plaintiff agreed to forgive provided that the Defendant does not default on the above payment
10 plan, along with Plaintiff's costs of suit in the amount of \$561.00, and Plaintiff's attorney's fees
11 in the amount of \$350.00, less amount paid, and together with interest on the principal balance
12 at the statutory rate per annum from June 26, 2006 until this debt is paid in full. Thereafter, Plaintiff
13 may obtain an execution from the Court and may demand payment in full on the remaining
14 Judgment balance.



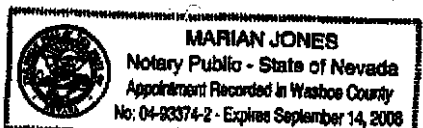
