ORDER APPOINTING PERMANENT GUARDIAN OF THE PERSON AND ESTATE AND FOR DIVISION OF COMMUNITY ASSETS AND INCOME

THIS MATTER came before the Court this date upon the verified Petition of DARYL B. DAVIS, by and through his attorney, HENRY W. CAVALLERA, ESQ. Appearing at the hearing were the Petitioner, DARYL B. DAVIS, and his attorney, HENRY W. CAVALLERA, ESQ.. The Court having received the evidence finds as follows:

- 11 The Ward was served with notice of the hearing as required by law.
- The Ward is of limited capacity and is unable to manage her financial affairs and obtain related services from local, state and federal agencies.
- 3. It is in the Ward's best interest that a Permanent Guardian of the Person and Estate be appointed.
- 4. The Guardian, DARYL B. DAVIS's mailing address is 2677 Wildhorse Lane, Minden, Nevada 89423. His telephone number is (775) 267-5566.

- That the Ward's spouse, DARYL B. DAVIS, should be 7. awarded all of his monthly fixed income in the sum of \$3,362.86, which should be adjusted annually with any cost of living increase.
- That the Court should set aside to DARYL B. DAVIS, a 8. spousal resource allowance in a sum of \$99,540.00, the federal maximum allowed by law, or the maximum resource allowance

determined by the federal government in the month that Medicaid is applied for on behalf of JOLENE M. DAVIS, from the parties joint resources.

- 9. That the separate assets and income of DARYL B. DAVIS should not be deemed as available for the costs of the necessities of life and medical needs of JOLENE M. DAVIS.
- 10. The Guardian should be directed to execute a Medicaid Qualified Income Trust on behalf of the Ward, <u>if necessary</u>, to obtain such benefits for JOLENE M. DAVIS.
- 11. That the Court issue an Order directing the Temporary or Permanent Guardian to establish a burial fund for the Ward in a sum up to ONE THOUSAND FIVE HUNDRED DOLLARS (\$1,500.00).
- 12. That the Court issue an Order directing the Guardian to establish and/or maintain a reserve account on behalf of the Ward with a balance of up to TWO THOUSAND DOLLARS (\$2,000.00).
- 13. That the Permanent Guardian be authorized to deed the residence located at 2677 Wildhorse Lane, Minden, Nevada, and more particularly described as follows:

Lot 174 in Block C, as set forth on FINAL MAP OF WILDHORSE, UNIT 5, a Planned Unit Development filed for record in the office of the County Recorder of Douglas County State of Nevada on January 27, 1993, in Book 193, Page 3866 as Document No. 298258, of Official Records of Douglas County, Nevada.

- 2. That the Guardian, DARYL B. DAVIS, having the posting of a bond waived, the Clerk of the Court shall issue Letters of Permanent Guardianship to DARYL B. DAVIS as Permanent Guardian of the Person and Estate of JOLENE M. DAVIS.
- 3. That the community spouse, DARYL B. DAVIS, is awarded all of his monthly income, which should be adjusted annually with any cost of living increase, pursuant to the Federal Medicaid law for his ongoing support.
- 4. That the Community Spouse, DARYL B. DAVIS, is awarded the sum of \$61,184.10, or in a sum up to \$99,540.00, or the maximum resource allowance determined by the federal government in the month that Medicaid is applied for on behalf of JOLENE M. DAVIS, as a spousal resource allowance.
- 5. IT IS FURTHER ORDERED that the separate assets and income of DARYL B. DAVIS are not to be deemed as available for the costs of the necessities of life and medical needs of JOLENE M. DAVIS.
- 6. The Guardian is hereby authorized to remove the name of the Ward from the following resources set aside for his spousal

Medicaid Qualified Income Trust on behalf of the Ward, if

necessary, to obtain such benefits for JOLENE M. DAVIS.
