ORDER FOR ISSUANCE OF LETTERS OF
SPECIAL ADMINISTRATION

13 THIS MATTER was brought on before the Court on the 11th day of
14 September, 2006, on the Verified Petition for Letters of Special
15 Administration with Will/Trust Annexed. Present in Court were the
16 Petitioner, FREDRIC C. STODIECK, together with his counsel, MICHAEL
17 SMILEY ROWE, ESQ. of ROWE & HALES, LLP.

18 Based upon the Verified Petition for Letters of Special
19 Administration with Will/Trust Annexed, and good cause appearing:

20 IT IS HEREBY FOUND, CONCLUDED AND ORDERED as follows:

21 1. The Court finds that WILLIAM R.R. STODIECK ("Decedent") died
22 on May 15, 2005. The Court has been provided with a certified copy of
23 the Decedent's Death Certificate. The Decedent was born on August 19,
24 1912, and had been assigned Social Security Number [REDACTED] 6157.

25 2. The Court finds that the Petitioner is currently serving as
26 the Successor Co-Trustee of the William R.R. Stodieck Trust Agreement
27 u.t.d. April 22, 2005.

1 3. The Decedent duly and properly executed a Will on April 22,
2 2005. The Decedent nominated the Petitioner as his Personal
3 Representative (Executor).

4 4. The Court finds that the beneficiaries and distributees of
5 the Trust have been provided with due and proper notice of the hearing;
6 Notice of Hearing being filed with the Court on the 16th day of August,
7 2006.

8 5. Petitioner has alleged, and the Court so finds, that
9 Petitioner, as Successor Trustee, would not normally petition this
10 Court for assistance in the administration of the Trust. However,
11 Petitioner has brought his Petition pursuant to NRS 164.015(4) for the
12 Court's assistance in the transfer of certain assets from the
13 Decedent's name to the Trust. The Court takes cognizance of the
14 Petition and the referenced statute, and hereby grants Petitioner the
15 Court's advice and instructions, and assistance in the administration
16 of the Trust.

17 6. The Court finds and concludes that good cause exists for the
18 appointment of a Special Administrator, in this case the Petitioner,
19 to assist in the transfer of the Decedent's assets to the Trust of the
20 Decedent.

21 ORDER

22 1. IT IS HEREBY ORDERED, based upon the above and foregoing
23 findings and conclusions, that the Petitioner, FREDRIC C. STODIECK
24 shall be appointed as the Special Administrator of the Estate of
25 WILLIAM R.R. STODIECK, Deceased, pursuant to the provisions of
26 NRS 140.010, NRS 164.015 and/or NRS 164.030.

27 2. BE IT FURTHER ORDERED that the Petitioner is appointed as
28 the Special Administrator of this estate for the purpose of

1 transferring all of the Decedent's assets to Petitioner as the
2 Successor Co-Trustee of the Decedent's Trust to be administered
3 pursuant to the terms of the Trust Agreement.

4 3. BE IT FURTHER ORDERED that the Clerk of this Court shall
5 issue letters of Special Administration to FREDRIC C. STODIECK, as
6 Special Administrator, for the purposes herein authorized. No bond
7 shall be required of the Petitioner to serve as Special Administrator
8 of the Decedent's estate.


9 4. BE IT FURTHER ORDERED that upon completion of the transfer
10 of the assets, Petitioner may request that the Court enter an order
11 without hearing terminating the Special Administration, and honorably
12 discharging the Petitioner from any further duties or requirements as
13 Special Administrator. The Court shall not require an accounting of
14 the Special Administrator at the time of termination of the special
15 administration, but Petitioner shall provide satisfactory evidence to
16 the Court, as exhibits to his request to terminate the special
17 administration, of the successful transfer of the assets of the
18 Decedent to the Decedent's Trust.
