2 from the pretrial conference.

3 **IT IS HEREBY ORDERED** that, after Court has reviewed the Notice  
4 and attached Settlement Agreement, the Court finds, concludes and  
5 orders that the Settlement Agreement be ratified, confirmed and  
6 approved.

7 The Plaintiffs and the Defendants are ordered to comply with  
8 each, every and all of the provisions of the Settlement Agreement.


9 Pursuant to the oral order of this Court on October 9, 2006,
