ORDER

The Court has read and considered the Petition for Instructions Regarding Distribution of Decedent's Estate Assets; Petition to Set Aside Estate Without Administration, filed by Gregory V. Holst on May 26, 2006, which contains a request to find Sandra Vasquez negligent for failure to lodge the will of William E. Reifer dated June 15, 2004. No written opposition, objection or other response was made to the Petition. A hearing on this matter was set for September 13, 2006 and Sandra Vasquez appeared with her counsel. With consent of counsel, the hearing was continued for purposes of settlement discussions. The hearing was re-set for January 4, 2007 and proper notice was given. Sandra Vasquez failed to appear.

Good cause appearing, the Court finds as follows:

- William Elwood Reifer died on August 12, 2004, in Douglas County, Nevada, and at the time of his death, left property in Douglas County, Nevada subject to the jurisdiction of this Court.
- 2. Decedent left a Last Will and Testament dated June 15, 2004 in which Sandra Vasquez was named Personal Representative. As the named Personal Representative, Sandra Vasquez had a duty to lodge the will with the Court and proceed with the probate. NRS 136.050.
 - 3. Vasquez did not lodge said will with this Court.
- 4. Vasquez did not file any written objection or opposition to Petitioner Gregory V. Holst's petition to find Vasquez negligent for violation of NRS 136.050(2). Vasquez's attorney, Mitchell Wright, withdrew as her counsel in the criminal matter effective December 21, 2006. Vasquez did not appear at the January 4, 2007 hearing or notify court or counsel of any reason she could not appear. Sandra Vasquez is not an infant or incompetent and is not in the U.S. military service.
- This issue was set for an evidentiary hearing and was properly noticed according to law.

BASED ON THE FOREGOING FINDINGS OF FACT, IT IS HEREBY ORDERED that Petitioner, the Replacement Trustee of the William Elwood Reifer Trust, recover of and from Sandra Vasquez the principal amount of \$\frac{38}{897.37}\$,
