14 This matter was brought on before the Court on the 19th day of  
15 March, 2007, as a result of the *Ex Parte* Verified Petition for  
16 Appointment of Guardian of Person and Estate filed February 23, 2007,  
17 by LYNN ENEARL, Douglas County Public Administrator and Public  
18 Guardian.

19 On March 19, 2007, the Court conducted a hearing on whether the  
20 temporary guardianship previously established should be continued. At  
21 the hearing the Court also considered the Petition for Modification of  
22 Guardianship filed by Kathleen Anne Maidlow and Eric Maidlow.

23 The Court, by separate order, will grant the Petition for  
24 Modification of Guardianship.

25 The Public Guardian has served in this matter by the Orders of  
26 the Court. She has performed all of her duties in exemplary fashion.

27 The Court is advised that as temporary Guardian, the Public

3 Guardian.

4 Based upon the above and foregoing, and good cause appearing:

5 **IT IS HEREBY ORDERED** that LYNN ENEARL, Douglas County Public  
6 Administrator and Public Guardian, shall be and she is hereby,  
7 honorably discharged as Guardian of the person and estate of the Adult  
8 Ward.

9  
10 **BE IT FURTHER ORDERED** that the guardianship estate shall  
11 obligated to pay for the temporary Guardian's fees which the Court has  
12 previously approved at the rate of \$65.00 per hour. Mrs. ENEARL has  
13 devoted 20 hours of time to this guardianship. It is the Order of the  
14 Court that the guardianship estate is obligated to pay to the Douglas  
15 County Public Guardian the sum of \$1,300.00.

16 In the order appointing temporary guardian, and in extending the  
17 temporary guardianship, the Court ratified, confirmed and approved of  
18 the Public Administrator's fee agreement with the firm of ROWE &  
19 HALES, LLP. It is the Order of this Court that the guardianship  
20 estate shall be obligated to pay the Public Administrator's attorney's  
21 fees and court costs. The attorney's fees are \$2,310.00; the court  
22 costs incurred are \$55.81. It is the Order of the Court that the
