FOURTH AMENDED DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS OF WILLOW CREEK HOMEOWNERS' ASSOCIATION THESE AMENDMENTS APPLY TO THE THIRD AMENDED DECLARATION THAT WAS FILED FOR RECORD IN THE OFFICE OF THE DOUGLAS COUNTY RECORDER ON MAY 8, 2006, IN BOOK 0506, PAGE 3498, AS DOCUMENT NO. 0674438, OF OFFICIAL RECORDS

Any provision of the CC&Rs that is not consistent with the provisions of NRS 116 shall be deemed to conform with the provisions of NRS 116 by operation of law.

CC&Rs Page 9 Item 4.6 <u>Trailers, Boats and Motor Vehicles</u>; No vehicle shall be stored, placed, maintained, constructed or repaired upon any Lot or street within Willow Creek unless it is kept within <u>an approved garage /structure or</u> an approved visual landscape screened area so as to be substantially hidden from view from any neighboring property. The visual landscape screen required above must be submitted for review to the Design Review Committee and approved by the Board prior to commencing planting. (Article V covers the approval process for a garage/structure.) This restriction applies to but is not limited to camper trucks, horse trailers, motor homes, recreational vehicles, watercraft, trailers and commercial vehicles. <u>This restriction does not apply to the parking of passenger vehicles that are in normal use.</u> No commercial vehicles shall be parked or stored on any Lot or on the lane of Willow Creek, except for a commercial vehicle providing services to Owners of Lots and, in such event, only for the duration necessary to provide such services.
