7. The exact amount due on the Judgment as of February 13, 2006, is \$8,191.18.

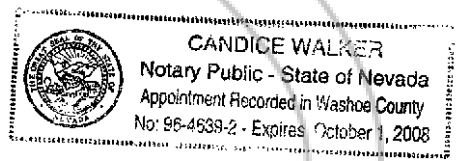


