6. The Judgment Debtor has no setoffs or counterclaims which would constitute payments or credits on the Judgment.

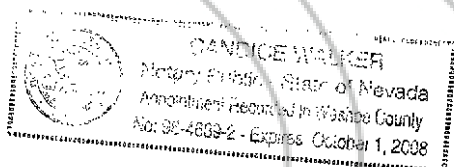
7. The exact amount due on the Judgment as of March 11, 2007, is \$5,359.44.
