## SPECIAL POWER OF ATTORNEY

### 1. Effectiveness and Duration.

This special power of attorney is effective immediately. I hereby ratify all that my attorney-in-fact shall lawfully do or cause to be done by virtue of this document, and I shall hold harmless and indemnify my attorney-in-fact from all liability for acts done in good faith.
