20 required by law, and having failed to appear, and the default of said Defendant having been
21 entered and evidence having been introduced in support of the claims alleged in Plaintiff's
22 Complaint, and the Court finding that there is no just reason for delay and that judgment should be
23 entered as prayed in Plaintiff's Complaint;

24 IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that Plaintiff,
25 HARVEYS TAHOE MANAGEMENT COMPANY, INC., a Nevada Corporation, doing
