to the Claimant Employment Fund, in the total amount of One Thousand Nine Hundred Ninety-



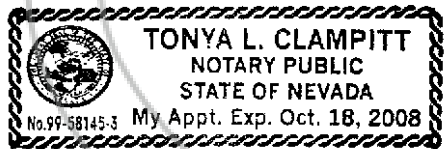
