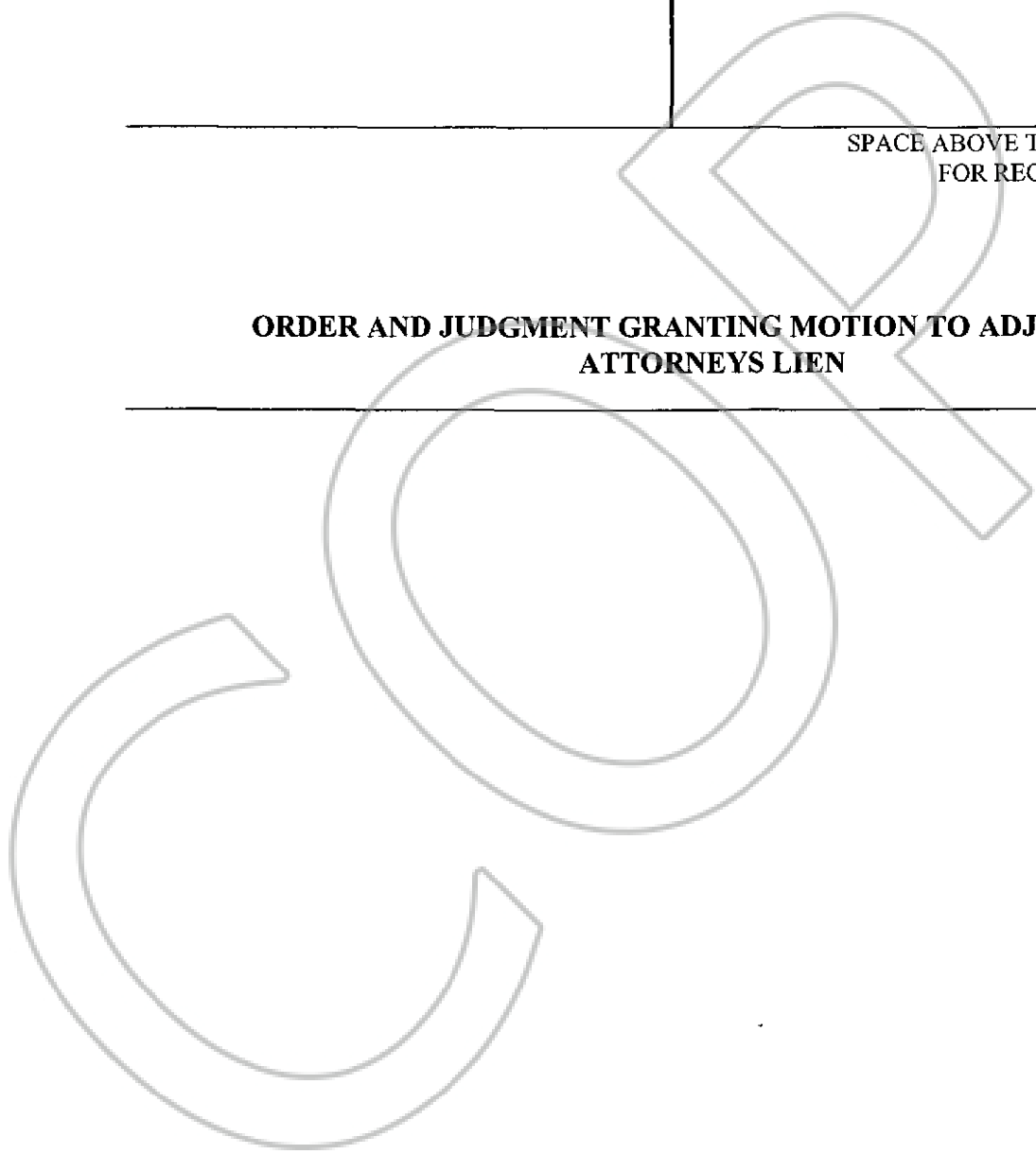

**ORDER AND JUDGMENT GRANTING

AND RELATED COUNTERCLAIMS

THIS MATTER, having come before the Court on the motion of Brooke · Shaw · Zumpft, wherein they request this Court grant their *Motion to Adjudicate Attorney's Lien*, and award them incurred fees in the amount of \$16,387.45 against WILLIAM J. WILKINS ("Wilkins"), and the Court, having considered the motion and all evidence in support thereof does hereby find, order and decree as follows:

1. The law firm of Brooke · Shaw · Zumpft has represented Wilkins in the above-encaptioned matter.
2. Wilkins has failed to satisfy his financial obligations with Brooke · Shaw · Zumpft, despite demands that he do so.
3. The amount of \$16,387.45 is reasonable and proper given the amount of time expended by Brooke · Shaw · Zumpft in this matter, both at the District Court and on Appeal.
4. Declare validity of lien.



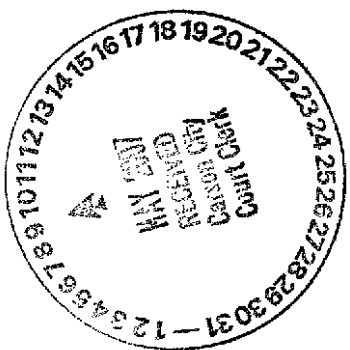
