ORDER FOR JUDGMENT

Upon the Stipulation for Judgment executed by the parties hereto, Plaintiff, HAWKER FINANCIAL CORPORATION ASSIGNEE OF ARROW FINANCIAL SERVICES, ASSIGNEE OF HOUSEHOLD BANK, ("Plaintiff"), by and through its attorney, JEFFREY G. SLOANE, ESQ., of the firm of KRAVITZ SCHNITZER SLOANE JOHNSON & EBERHARDY, and the Defendants, SUSAN S MARLEY ("Defendants") that the Plaintiff has Judgment against said defendants for the sum of \$2,592.72, together with interest at the rate of 10.25 percent per annum from DATE OF JUDGMENT, plus attorneys fees in the amount of \$570.40 and court costs of \$178.00, and all costs accrued after judgment.

1 IT IS HEREBY ORDERED, ADJUDGED AND DECREED that the Plaintiff have
2 Judgment against said Defendants for the sum of \$2,592.72, together with interest at the rate of
3 10.25 percent per annum from DATE OF JUDGMENT, plus attorneys fees in the amount of
4 \$570.40 and court costs of \$178.00, and all costs accrued after judgment.

6 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the aforementioned
7 Judgment shall be paid as follows:

8 Beginning on or before the 16 day of JANUARY, 2007, Defendants shall pay Plaintiff
9 ONE HUNDRED FORTY FOUR DOLLARS AND 00/00 Dollars, (\$144.00), per month, and a
10 like amount on or before the 16 day of each month thereafter until the full amount of the
11 Judgment has been extinguished.

13 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that payments shall be
14 made payable to "KSSJE" and delivered or mailed to the offices of KRAVITZ SCHNITZER
15 SLOANE JOHNSON & EBERHARDY, Attention: Payments, 1389 Galleria Drive, Suite 200,
16 Henderson, NV 89014 and shall be received by said offices on or before the aforementioned
17 dates, referencing Account 0501613100061419 on all payments.

19 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that in the event the
20 Defendants fail, neglect or refuse to pay any such payment on or before its due date, then all
21 sums remaining due under such Judgment shall become due and owing and entry and execution
22 may thereupon issue without benefit of notice to the Defendants.

24 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that upon payment in full
25 of the amounts aforementioned in the manner provided for herein, Plaintiff shall file a
26 Satisfaction of Judgment.

27 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that upon payment in full
28 of the amounts aforementioned in the manner provided for herein, Plaintiff shall extinguish all

1 lien rights it may have in any property of the Defendant.

2 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that pursuant to Nevada
3 Rules of Civil Procedure 41(e) that enforcement of this Judgment may be made by Plaintiff
4 against Defendant at any time in the future should Defendant default on the payments, and that
5 any limitation stated in Nevada Rules of Civil Procedure 41(e) is hereby waived in its entirety by
6 Defendant.
