**AMENDMENT  
TO CORRECT  
DEED OF TRUST**

THIS AMENDMENT TO CORRECT DEED OF TRUST IS BEING RECORDED TO CORRECT THE LEGAL NAME OF THE GRANTOR IN THE ORIGINAL DEED OF TRUST FILED ON NOVEMBER 30, 2004 AT BOOK 1104 AT PAGE 13769 WITH THE DOUGLAS COUNTY, NEVADA REGISTER OF DEEDS.

THIS AMENDMENT TO CORRECT DEED OF TRUST (this "Amendment"), is entered into as of the 21<sup>st</sup> day of June, 2007, by and among NEVADA SENIOR PROJECTS, LLC, a Nevada limited liability company ("Grantor"), whose mailing address is 1189 Kimmerling Road, Gardnerville, Nevada, 89460-7580, and BRUNING STATE BANK, a Nebraska state bank ("Lender" and "Trustee"), whose mailing address is 104 Main Street, P.O. Box 100, Bruning, Nebraska 68322-0100.

**RECITALS**

WHEREAS, Lender loaned to Grantor in immediately available funds the sum of Four Million One Hundred Sixty Six Thousand Seven Hundred and 50/100ths Dollars (\$4,166,700.50) represented by that certain Promissory Note dated August 9, 2005 (evidencing a refinancing of Loans 42332, 42607, 42973 to permanent term), executed by Grantor for the benefit of Lender and secured by that certain Deed of Trust (the "Deed of Trust") dated November 1, 2004, by and among Grantor, Lender and Trustee, as filed on November 30, 2004, at Book 1104 at Page 13769 with the Douglas County, Nevada Register of Deeds; and

WHEREAS, due to a typographical error in the legal name of the Grantor as stated in the Deed of Trust, the Grantor, Lender and Trustee desire to enter into this Amendment to correct such error.

NOW THEREFORE, for and in consideration of the recitals set forth above and other good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, and intending to be legally bound, Grantor hereto agrees as follows:

1. The Grantor's name as it appears in the Grantor's name and address on page 1 of the Deed of Trust shall be changed from "Nevada Seniors Project, LLC" to "Nevada Senior Projects, LLC."
2. The Grantor's name as it appears in Section 1 titled "Date and Parties" on page 1 of the Deed of Trust shall be changed from "Nevada Seniors Project, LLC" to "Nevada Senior Projects, LLC."

3. The Grantor's Entity Name as it appears in the Grantor's signature line on page 12 of the Deed of Trust shall be changed from "Nevada Seniors Project, LLC" to "Nevada Senior Projects, LLC."

4. The Grantor's Name of Business or Entity as it appears in the attestation clause on page 13 of the Deed of Trust shall be changed from "Nevada Seniors Project, LLC" to "Nevada Senior Projects, LLC."

5. Grantor hereby agrees that, except as specifically amended hereby, the terms and provisions of the Deed of Trust are hereby ratified and shall remain in full force and effect as of the date first executed. By execution hereof, Grantor, Lender and Trustee concur with all of the provisions contained in this Amendment and acknowledge and agree that an original of this Amendment may be filed with the Register of Deeds of Douglas County, Nevada.

6. Grantor hereby acknowledges the receipt of a copy of this Amendment.

7. This Amendment may be executed in counterparts, each of which shall constitute as an original and all of which, taken together, shall constitute a single agreement.

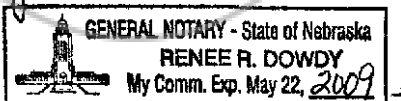

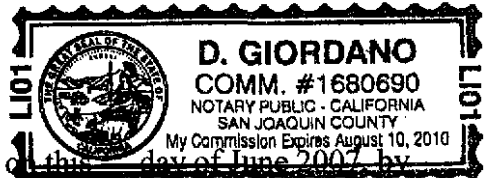

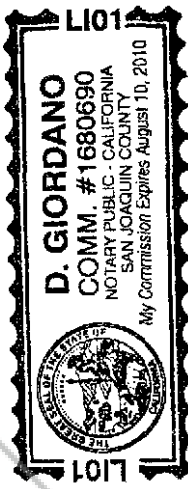
