UTILITY EASEMENT

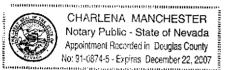

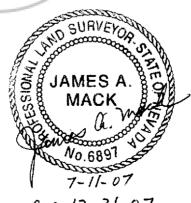

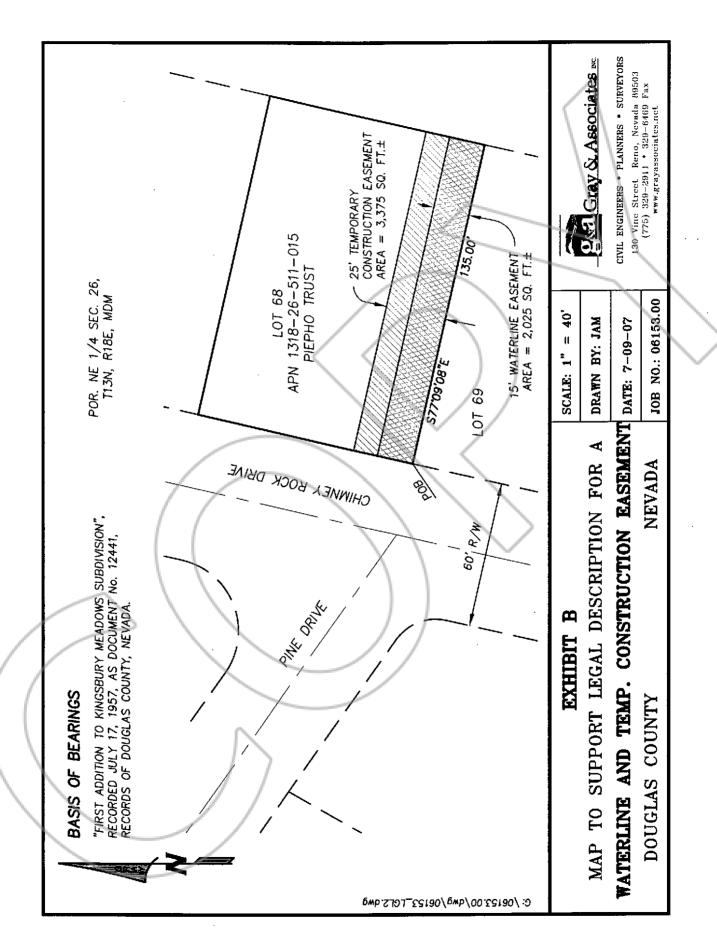
