
THIS MATTER having come on in accordance with the provisions of Section 612.630,

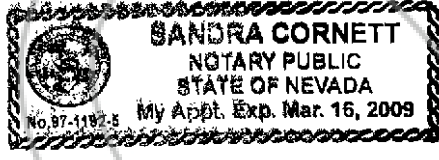
