dated September 10, 2007, party of the second part.


WITNESSETH:

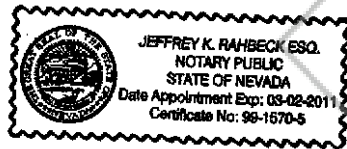
