The tank went on line today therefore the project is Substantially Complete, I will issue a Contract Change Order to extend the completion dates of section 4.02 of the agreement accordingly, the new date for substantial completion will be November 16, and for final pay December 16, 2007. Here is a *preliminary* punch list generated on Wednesday the 14th, we need to schedule a walk thru when you are closer to complete per the contract documents:

- 1. Remove construction debris including the PVC piping used in the fire protection.
- 2. Adjust valve cans to grade in AC areas and provide PCC collars in dirt areas.
- 3. Trim CMP at basin exit to +/- 1in and provide grate with max 4in openings.
- 4. Straighten future power conduits so that a vertical riser will attach.
- 5. Provide SPPCo. Approval for work done on conduits.
- 6. Clean fan hole on pump house.
- 7. Point, patch and sac the PCC roof of the pump house.
- 8. Clean out the Pump house.
- 9. Provide keys to pump house.
- 10. Remove the bituthene water shield at the key stone face.
- 11. Provide ladders with the OSHA extension for both vaults.
- 12. Construct the edge of pavement drain as shone on sheets no 4A.
- 13. Revegetate disturbed areas per note on sheet 4A.
- 14. Redo the conduit at tank base to: 1, remove tripping hazard 2, to comply with code on no. of bends.
- 15. Remove water couplings and install ridged couplings on ridged conduit.
- 16. Remove tape from man way and paint.
- 17. Finish fence.
- 18. Complete SCADDA.
- 19. Remove temp tanks.
- 20. Pave hole where temp lines go under ground.
- 21. Clean staging area.
