ABANDONMENT: DA 06-142

AN ORDER OF ABANDONMENT VACATING A PORTION OF THE INSPIRATION DRIVE RIGHT-of-WAY TOTALING 1,882 SQUARE FEET ALONG THE EASTERN FRONTAGE OF 636 INSPIRATION DRIVE, ASSESSOR'S PARCEL NUMBER (APN) 1318-10-413-016 IN THE ZEPHYR KNOLLS PLAN'NING AREA OF DOUGLAS COUNTY, NEVADA

Douglas County, a political subdivision of the State of Nevada, presently holds an easement interest for a strip of land for roadway purposes located within a portion of the East ½ of the Southwest ¼ of Section 10, Township 13 North, Range 18 East, Mount Diablo Meridian, commencing at the southwest corner of Lot 90 as shown on the map of Zephyr Knolls Unit No. 4, filed in the office of the Recorder, Douglas County, Nevada on October 14, 1957 as Document Number 12699.

Douglas County, pursuant to the provisions of NRS 278.480, may vacate or abandon by formal order any portion of a public roadway.

On January 9, 2007, the Douglas County Planning Commission conducted a public hearing in conformance with the provisions of NRS 278.240 to take testimony on the above-mentioned abandonment for Kevin Lane, owner of APN 1318-10-413-016, and did find that the release of the aforesaid described easement was not inconsistent with the Douglas County *Master Plan*.

On February 15, 2007, the Douglas County Board of Commissioners held a public hearing to take testimony for said abandonment and did find that the subject easement is in excess of the needs of Douglas County, and that the public will not be materially injured by the abandonment.

On 12/05/07, a certain "Record of Survey Supporting Order of Abandonment" dated 12/05/07 was recorded in Book 12/07 at Page 358, Document Number 07/14349, Official Records of Douglas County, NV.

Now be it ordered by the Board of Douglas County Commissioners that the aforesaid portion of right-of-way, as depicted in the attached Legal Description provided in *Attachment* "B" and shown on the site plan provided as *Exhibit B* subject to a public utility/road maintenance easement and a drainage easement, as described in *Attachment* "B", is hereby granted to Kevin Lane, subject to the stipulations below.

The abandonment has been made subject to and has met the following conditions of approval prior to the recordation of this abandonment:

- 1. The applicant shall submit a Record of Survey with the Order of Abandonment for review and approval showing the right-of-way to be abandoned.
- 2. The applicant shall establish a combined, 7-foot public utility easement (P.U.E.) and road maintenance easement along the road frontage.

4. The applicant shall establish a drainage easement for the existing gravel drip line. This easement shall include a maintenance area.

RECORD OF SURVEY REQUIREMENTS:

- 5. The final record of survey map shall show or provide a note for the following:
 - a. The dedication of right-of-way for Inspiration Drive will not create a new parcel.
 - b. Drainage easements as necessary for mitigating onsite, offsite, and cross-lot drainage impacts. All drainage easements shall be shown as private.
 - c. Maintenance of all drainage facilities and easements shall be the responsibility of the individual property owner or other private entity, including a homeowner's association. Douglas County rejects any offer of dedication of drainage facilities or drainage easements.
 - d. Obstructing the flow or altering the course of a drainage channel is prohibited, unless permitted by authorizing agency.
 - e. No obstructions are allowed in the 7-foot P.U.E. and road maintenance easement.




