
PARTIAL RELEASE AND PARTIAL RECONVEYANCE

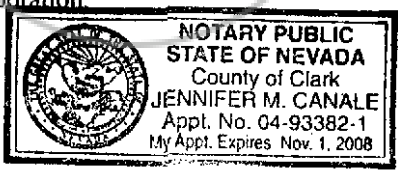


