



ORDER SETTLING FIRST & FINAL ACCOUNT AND FOR FINAL DISTRIBUTION

Deceased.

The Petition of Nancy Di Salvo (the "Petitioner"), the Personal Representative of the Will and Estate of Nicholas Peter Di Salvo, also known as Nicholas P. Di Salvo, deceased, for the settlement of the first and final accounting and for final distribution of the estate came on regularly for hearing this day. No person having appeared to contest the Petition. and on proof duly made to the satisfaction of the Court, the Court now finds the following:

- 1. Notice of the hearing on the Petition has been duly given as required by law. An Affidavit of Mailing of the Notice of Hearing has been filed with the Clerk of the Court.
- 2. Nicholas Peter Di Salvo, also known as Nicholas P. Di Salvo (the "Decedent"), died on December 9, 2005, in Reno, Washoe County, Nevada. The Decedent, at the time of his death, was a resident of Douglas County, Nevada, and left an estate in the State of Nevada subject to probate administration.

- 3. The Decedent's Will dated December 28, 1992 was admitted to probate by the Order of the Court dated April 24, 2007. The Petitioner was appointed the Personal Representative of the Decedent's Will and estate, and Letters Testamentary were issued to her on May 14, 2007. The Petitioner has been serving in that capacity since appointment.
- 4. The Order dated April 24, 2007, provided for the estate to be administered as a Full Administration.
- 5. Notice to Creditors has been given for the time and in the manner required by law, and the time for filing or presenting claims has expired. No claims have been filed against the estate.
- 6. Federal and state estate tax returns were due for the estate. All federal and state estate tax returns have now been filed and all taxes due thereon have been paid. The returns have not yet been audited and the Petitioner has not been released from responsibility for the same. However, the estate is to be distributed to the Decedent's family trust of which the Petitioner is the Trustee, and which trust will be responsible for the satisfaction of any additional taxes or expenses related to audit.
- 7. All federal and state income tax returns due on behalf of the Decedent and the estate as of the date of the Petition have been filed, and the taxes shown due thereon have been paid. Any additional income tax returns due on behalf of the Decedent and the estate will be timely filed, and the taxes shown due thereon will be timely paid. The returns that have been filed have not yet been audited, and the Petitioner has not yet been released from personal liability for federal and state income tax liabilities due from the Decedent and the estate. The estate should be distributed subject to any additional

income tax liabilities that might be due from the estate.

- 8. On May 29, 2007, Petitioner filed an Inventory, Appraisement, and Record of Value (the "Inventory") with the Court showing the value of the probate estate to be One Million Six Hundred Thirty Five Thousand and 00/100 Dollars (\$1,635,000.00).
- The Petitioner has filed a First & Final Accounting for the Decedent's estate.
  The First & Final Accounting appears to be in order and should be approved as filed.
- 10. The Petitioner has performed all duties required of her as Personal Representative of the Decedent's Will and estate from the time of appointment through the current time. All of the debts of the Decedent and the estate and all administration expenses and charges have been paid. The estate is now ready for distribution and is in a condition to be closed.
- 11. The Petitioner has waived her right to statutory commissions for services rendered as Personal Representative of the Decedent's Will and estate.
- 12. The law firm of Maupin, Cox & LeGoy has performed valuable services to the Personal Representative and estate, and is entitled to reasonable compensation for such services. However, the law firm and Petitioner have agreed that legal fees and costs will be paid from the Di Salvo 1992 Living Trust, and accordingly, the law firm has waived its right to recovery of such fees from the probate estate.
- 13. The estate is in a condition to be closed and should be distributed in accordance with the Decedent's Will. Paragraph Fourth of the Decedent's Will provides for the distribution of the Decedent's personal effects to the Decedent's wife, Nancy Di Salvo. In addition, Paragraph Fifth of the Decedent's Will provides for the residue of the Decedent's estate to be distributed to the Di Salvo 1992 Living Trust dated December 28,

1992. The assets of the probate estate, together with any other assets of the Decedent or of the estate that are not now known or discovered, should be distributed pursuant to these provisions. Accordingly, the estate should be distributed as follows:

- a. To Nancy Di Salvo, all of the Decedent's interest in and to personal, household and garden effects of every kind, including by way of illustration only and not by way of limitation, clothing, jewelry, furniture and furnishings, personal automobiles, boats, country club memberships, artwork and other tangible articles of a personal nature.
- b. To Nancy Di Salvo, as Trustee of the Di Salvo 1992 Living Trust dated December 28, 1992, the Decedent's entire right, title, and interest in the real property commonly known as 1274 Centerville Lane, Gardnerville, Douglas County, Nevada, Assessor's Parcel No.1220-05-000-014.
- c. To Nancy Di Salvo, as Trustee of the Di Salvo 1992 Living Trust dated December 28, 1992, the Decedent's entire right, title, and interest in the real property commonly known as 1282 Centerville Lane, Gardnerville, Douglas County, Nevada, Assessor's Parcel No.1220-04-002-005.
- d. The Decedent's entire remaining estate, together with any other assets of the Decedent or of the estate that are not now known or discovered, to Nancy Di Salvo, as Trustee of the Di Salvo 1992 Living Trust dated December 28, 1992.

BASED UPON THE ABOVE, the Court now orders the following:

A. The First & Final Account is settled, allowed and approved as filed, and all of the acts and transactions of the Petitioner, as the Personal Representative of the Decedent's Will and estate, as disclosed in the Petition, are confirmed and approved.
