MODIFICATION OF NOTE SECURED BY

NOW THEREFORE, in consideration of the mutual benefit of the parties hereto, said note hereinabove referenced shall be modified as to the following particulars:

NEW PAYMENT TO BE \$100.00 PER MONTH . ANY INTEREST DEFICIT WILL BE ADDED TO THE PRINCIPAL AT THE END OF THE NOTE. SAID MODIFICATION IS FOR 6 MONTHS (TOTAL PAYMENT TO BE \$108.00, TO INCLUDE \$8.00 FEE TO BE PAID TO EVERGREEN NOTE SERVICING.)

THIS AGREEMENT is modification only, and not a novation; and except as provided herein, all of the original terms and conditions set forth in Deed of Trust and Note secured thereby, shall remain in full force and effect, and shall further be binding upon and inure to the heirs, successors and assigns forever to the parties hereto.
