# SPECIAL POWER OF ATTORNEY

1. Effectiveness and Duration.

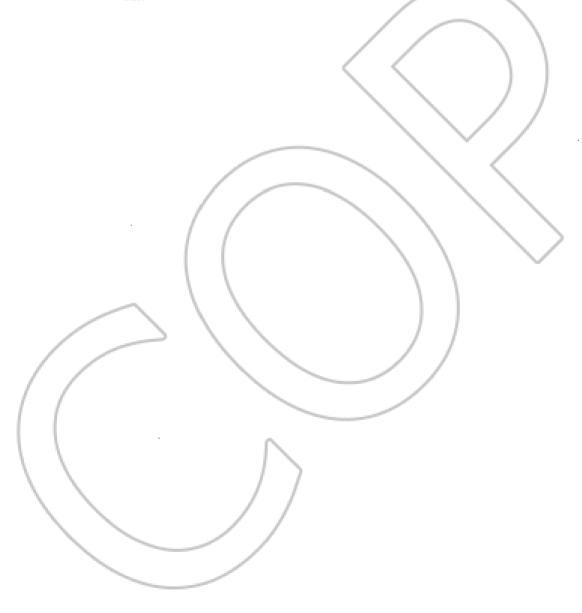
