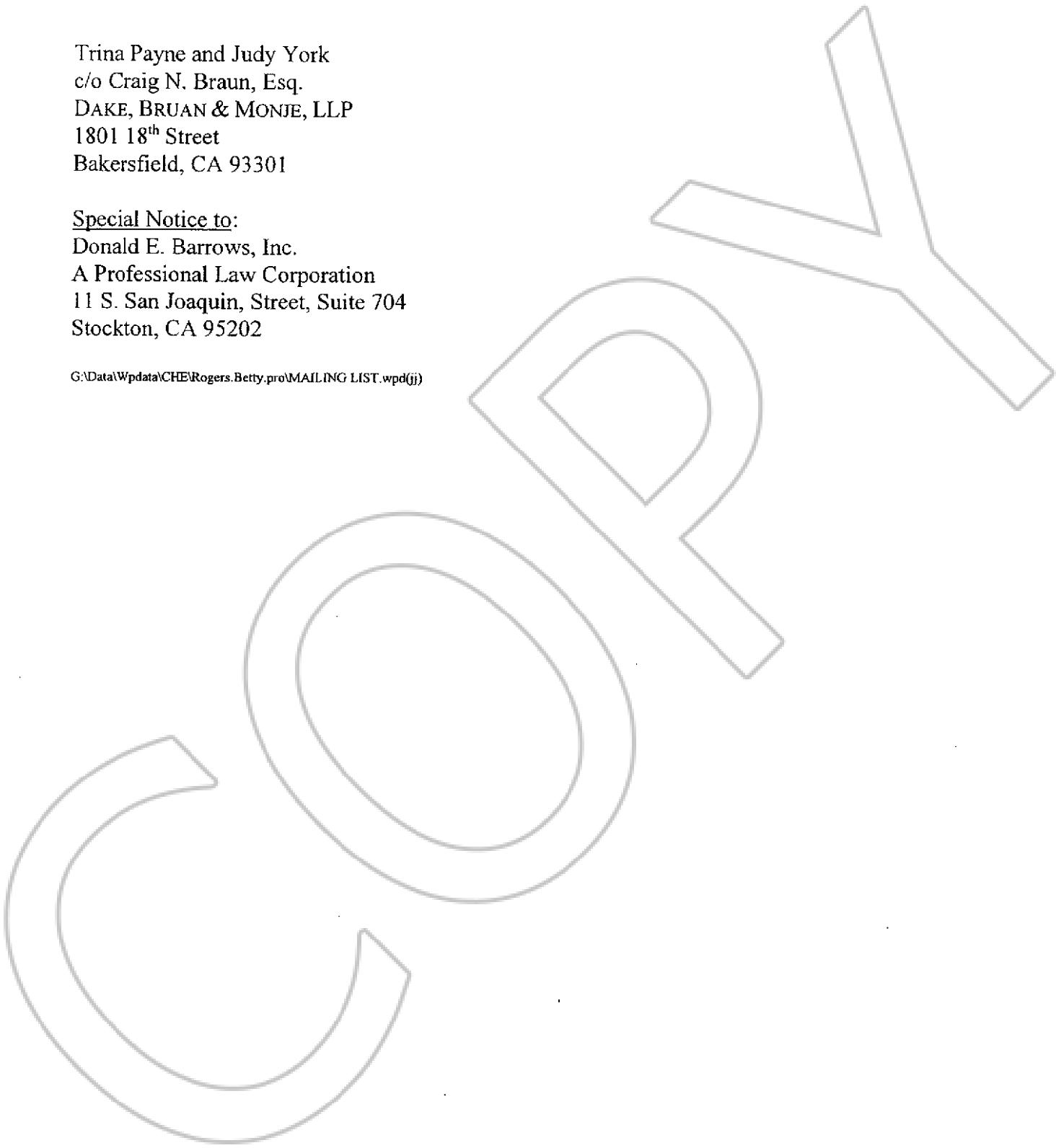

- 3. The Co-Administrators are jointly and severally surcharged in the following amounts: \$345,742.70 for unauthorized loans; \$1,500.00 for the unauthorized sale of personal property; and \$6,855.13 for unauthorized expenses; with respect to Co-Administrator Trina Payne, there may be an offset against the surcharge based on her distributive share of the estate which will be subject to later calculations; and
- 4. The Co-Administrators are removed from office and Rose Medford is appointed as successor administrator, subject to the court's review of her petition to be appointed as successor administrator and any objections thereto, with the hearing on her petition to be appointed successor administrator scheduled for November 14, 2007, at 8:30 a.m. in department 35.
