NOTICE OF LIEN—CORPORATION
(Nevada Revised Statute §108.226)

NOTICE IS HEREBY GIVEN that Jeffrey Wilson, D.B.A. Central Systems Electric, Inc., in his official capacity as President of Central Systems Electric, Inc., claims a Mechanic's and Materialsman's Lien upon the property hereinafter particularly described, which property is located in the County of Douglas, State of Nevada, and which claim is made pursuant to the laws of the State of Nevada, particularly Chapter 108 of the Nevada Revised Statutes, as amended, for the value of \$1544.00 furnished by lien claimant for the improvement of real property hereinafter particularly described, located in the County of Douglas, State of Nevada.

That the whole of the real property hereinafter particularly described has been or is in the process of improvement and is reasonably necessary for the convenient use of occupation of said property.

(\$1544.00); that to date moneys owing is Fifteen hundred forty four dollars and 00 cents, (\$1544.00).
