**NOTICE OF LIEN - CORPORATION**

(Nevada Revised Statute §108.226)

(\$1320.01); that to date moneys owing is Thirteen hundred twenty dollars and 01 cents, (\$1320.01).

5. Lien claimant is informed and believes that the work of improvement has been completed.
