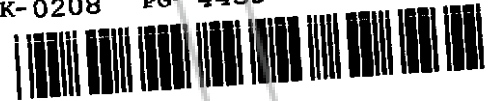

**NOTICE OF LIEN—CORPORATION**

(Nevada Revised Statute §108.226)

NOTICE IS HEREBY GIVEN that Jeffrey Wilson, D.B.A. Central Systems Electric, Inc., in his official capacity as President of Central Systems Electric, Inc., claims a Mechanic's and Materialsman's Lien upon the property hereinafter particularly described, which property is located in the County of Douglas, State of Nevada, and which claim is made pursuant to the laws of the State of Nevada, particularly Chapter 108 of the Nevada Revised Statutes, as amended, for the value of \$920.01 furnished by lien claimant for the improvement of real property hereinafter particularly described, located in the County of Douglas, State of Nevada.

That the whole of the real property hereinafter particularly described has been or is in the process of improvement and is reasonably necessary for the convenient use of occupation of said property.

Claimant further states:

1. That the name of the owner(s) or reputed owner(s) of the premises sought to be charged is/are, James Roy Gann Jr.
2. That the name of the person by whom lien claimant was employed and to whom lien claimant furnished lighting fixtures, in connection with the project is THE SPRINGS VI LLC at 990 Ironwood Drive, Minden, Nevada.
3. That the terms, time given and conditions of the contract were to furnish Lighting fixtures commencing November 30, 2007 and completing the work on November 30, 2007, for the amount of Nine hundred twenty and 01 cents, (\$920.01), with payment to be made within 30 days of invoice date. The first work by the lien claimant commenced on November 30, 2007.

4. That lighting fixtures have been furnished to and actually used upon the above-described project in the amount of Nine hundred twenty dollars and 00 cents, (\$920.01); that to date moneys owing is Nine hundred dollars and 01 cents, (\$920.01).

5. Lien claimant is informed and believes that the work of improvement has been completed.

6. That a demand for payment has been made by lien claimant and that no part or portion of the amount due and owing has been paid; that there are no further off-sets to the claim and that the sum of Nine hundred twenty dollars and 01 cents, (\$920.01), plus interest is now due and owing to lien claimant on account of Central Systems Electric, Inc., furnished as above specified and that the undersigned claims a lien upon the real property particularly described herein for said sum, together with interest and attorney's fees as provided by law.
