DEED UPON LIEN FORECLOSURE (The Ridge Sierra)

THIS DEED UPON LIEN FORECLOSURE is made on January 17, 2008, by STROSER ASSETS, INC., a Nevada corporation, as Agent for Q. M. CORPORATION, a Nevada corporation, successor in interest to the RIDGE SIERRA PROPERTY OWNERS ASSOCIATION, a Nevada corporation, by Assignment recorded January 14, 2008, as Document No. 0716186, Douglas County, Nevada, records, herein Grantor and Q.
