CERTIFICATE OF THE  
DECLARATION OF TRUST OF DAVID ANTHONY LA BARBARA

THE UNDERSIGNED hereby swears (or affirms) under penalty of perjury, that the following assertions are true of her own personal knowledge:

1. **Name and Date of Trust.** DAVID ANTHONY LA BARBARA, as Settlor and Trustee, executed the DECLARATION OF TRUST OF DAVID ANTHONY LA BARBARA on 21 FEBRUARY, 2008, thereby creating a revocable living trust.

2. **Trustees.** DAVID ANTHONY LA BARBARA shall serve as the initial Trustee of this trust. If DAVID ANTHONY LA BARBARA shall for any reason cease to act as Trustee, then PRIYANKA VARNI shall act as successor Trustee. If PRIYANKA VARNI shall for any reason cease to act as Trustee, then ANTHONY VARNI shall act as successor Trustee.

No bond shall be required of any person named in this instrument as a Trustee for the faithful performance of his or her duties as Trustee.

No successor Trustee shall be liable for any act, omission, or default of a predecessor Trustee. Unless requested in writing within sixty (60) days of appointment by an adult beneficiary of a trust, no successor Trustee shall have any duty to investigate or review any action of a predecessor Trustee and the successor Trustee may accept the accounting records of the predecessor Trustee showing assets on hand without further investigation and without incurring any liability to any person claiming or having an interest in the trust.

3. **Title of Assets.** The form in which title to assets of the trust is to be taken is as follows: DAVID ANTHONY LA BARBARA, Trustee of The DECLARATION OF TRUST OF DAVID ANTHONY LA BARBARA TRUST dated 21 FEBRUARY, 2008.


4. **Powers of Trustees.**  
In order to carry out the provisions of the trust created by this instrument, the Trustee shall have all of the powers conferred upon such a Trustee by the trust laws of the State of Nevada.

5. **Revocation and Amendment.**

So long as Settlor is living, the trust may be revoked, terminated, or amended in whole or in part by an instrument in writing, signed by Settlor and delivered to the Trustee, if the Trustee is not the Settlor. If the Trustee is the Settlor, delivery of the instrument to the Trustee is unnecessary. On revocation, the Trustee shall promptly deliver to Settlor all of the designated portion of the trust assets.

DAVID ANTHONY LA BARBARA, the Settlor and Trustee of The DECLARATION OF TRUST OF DAVID ANTHONY LA BARBARA, under the terms of the Declaration of Trust, hereby certifies that this Certificate of The DECLARATION OF TRUST OF DAVID ANTHONY LA BARBARA is an accurate summary of the provisions of the Trust Agreement, that the Declaration of Trust has not been revoked or amended to make any representations contained herein incorrect, and that the signature below is of the currently acting Trustee designated under the terms of the Declaration of Trust identifying the trust, naming the Trustee and the successor Trustees, and specifying the powers of the Trustees. Any person or entity transacting business with the Trustees may rely upon this Certificate without reviewing the entire Declaration of Trust.
