JUDGMENT

WHEREAS, Petitioner, State of Nevada, Department of Business and Industry, Division of Consumer Affairs, ex. rel. James Campos, Commissioner ("Petitioner"), issued a Findings of Fact Conclusions of Law and Order against Respondent, Robert Yocum, d.b.a. Prospector and Treasure Hunters Headquarters, Inc. ("Respondent"), on February 6, 2007;

WHEREAS, Petitioner's Findings of Fact Conclusions of Law and Order requires, among other things, that Respondent pay restitution to his victims in the amount of \$2,984.00 and pay administrative costs to Petitioner in the amount of \$823.50;

WHEREAS, Respondent failed to comply with Petitioner's Findings of Fact Conclusions of Law and Order, and the Court granted Petitioner's Petition for Order Compelling Compliance with Administrative Decision and for Other Relief and awarded attorney's fees and costs in the amount of \$250.00;


