DEFINITIONS

(A) "Security Instrument" means this document, which is dated MARCH 07, 2008, together with all Riders to this document.

(B) "Borrower" is Guillaume Etchechury and Judith Anne Etchechury, Trustees of the Etchechury Family Trust dated February 15, 1996. Borrower is the trustor under this Security Instrument.

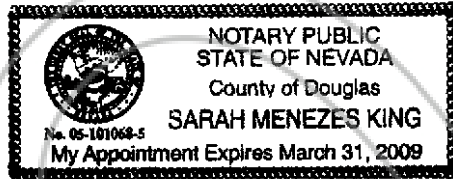
