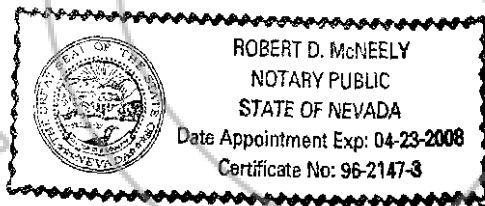


EXHIBIT A

Legal Description
