All that certain property located and situated in Douglas County, State of Nevada, specifically described as follows:



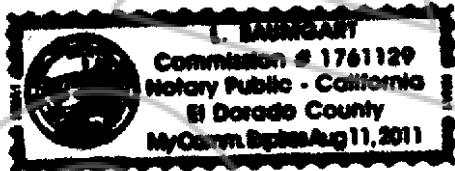
