ABSTRACT AND CERTIFICATE OF TRUST

The undersigned hereby certify that on April 16, 2008, they created a revocable estate planning trust. This trust is known as the "THE ANDREW S. RICE & JANICE S. RICE TRUST dated April 16, 2008.

THE PARTIES FURTHER DECLARE AND CERTIFY AS FOLLOWS:

Description of Trust

The parties hereto desire to confirm the establishment of a revocable trust on April 16, 2008, for the benefit of the Trustors (as husband and wife) and containing, *inter alia*, the following provisions:

- 1. The Trustors are designated as the Trustees to serve until both of their deaths, resignations or incompetence.
- 2. Upon the removal of both original Trustees, initial Successor Co-Trustees are designated as ELIZABETH J. RICE and NEIL J. BERSTON, JR...
- Upon the death of either Trustor, the net income of the Trust estate shall be distributed or applied to or for the benefit of the surviving trustor during his or her

lifetime.

- 4. Any Trustee/Trustor has the power and authority to manage and control, buy, sell and transfer the Trust property, in such manner as the Trustee may deem advisable, and shall have, enjoy and exercise all powers and rights over and concerning said property and the proceeds thereof as fully and amply as though said Trustee were the absolute and unqualified owner of same, including the power to grant, bargain, sell and convey, encumber and hypothecate, real and personal property, and the power to invest in corporate obligations of every kind, stocks, preferred or common, and to buy stocks, bonds and similar investments on margin or other leveraged accounts, except to the extent that such management would cause inclusion of an irrevocable trust in the estate of a Trustee.
- 5. Upon the death of both Trustors, the Trust estate continues or shall be distributed in whole or in part for the benefit of other named beneficiaries according to the terms of the Trust.
