ABSTRACT & CERTIFICATE OF TRUST

The undersigned trustor has established a Revocable Living Trust which is to be known as the:

THE 1998 WESLEY TAYLOR FAMILY TRUST

The undersigned further declares and certifies that:

1. The trustor is designated as the trustee to serve until his death, resignation or incompetence.
2. The trustor may amend, in whole or in part, or may revoke this agreement in writing at any time.
3. The original trustee shall have full authority for the trust to act independently in performing transactions on behalf of the trust.
4. The original trustee during his lifetime retains the unlimited right to withdraw income and principal from the trust estate up to the whole thereof as the original trustee may from time to time deem necessary or advisable.
5. Any trustee has the power and authority to manage and control, buy, sell and transfer the trust property, in such manner as the trustee may deem advisable, and

shall have, enjoy and exercise all powers and rights over and concerning said property and the proceeds thereof as fully and amply as though said trustee were the absolute and unqualified owner of same, including the power to grant, bargain, sell and convey, encumber and hypothecate, real and personal property, and the power to invest in corporate obligations of every kind, stocks, preferred or common, and to buy stocks, bonds and similar investments on margin or other leveraged accounts, except to the extent that such management would cause inclusion of an irrevocable trust in the estate of a trustee.

6. In the event the original trustee cannot or will not serve as trustee, the Successor Co-Trustees are designated as WILLIAM VAN LEUVEN, JEFFREY JARBOE and NICOLE GESSELMAN until certain secondary trusts only remain undistributed. At that time, WILLIAM VAN LEUVEN is authorized to act alone as successor trustee.

7. When there is more than one successor trustee acting simultaneously with other designated trustees, the co-trustees so serving must act in concert.

8. Upon the death of the original trustor, the trust estate continues or shall be distributed in whole or in part for the benefit of other named beneficiaries according to the terms of the trust.

9. The identifying number of the trust, while the original trustor/trustee survives, will be the Social Security Number (or Employer Identification Number) of the trustor on all accounts held in the name of the Trust.

10. The situs of the trust is the State of Nevada.

11. The use of this Abstract and Certificate of Trust is for convenience only and the Trust is solely controlled as to provisions and interpretations by the trust agreement as amended, and any conflict between this abstract and the trust agreement as amended shall be decided in favor of the trust agreement as amended.

12. The trust has not been revoked or amended to make any representations contained in the certification incorrect, and the signature contained herein is that of the currently acting sole original trustor and trustee.
