28 judgment has been satisfied, and;

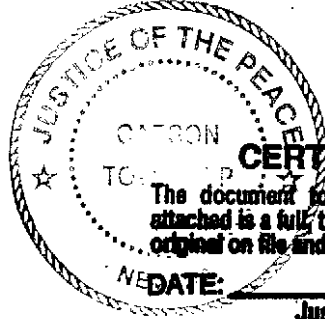
