DEED OF PARTIAL RECONVEYANCE

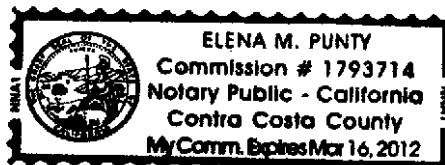
