This matter having been set for Hearing before this Court on June 9, 2008, Plaintiff, KINGSBURY CROSSING OWNERS' ASSOCIATION, a Nevada non-profit corporation, appearing by and through its attorneys, ALLISON, MacKENZIE, PAVLAKIS, WRIGHT & FAGAN, LTD., the Defendants being OCWEN FEDERAL BANK FSB, formerly known as BERKELEY FEDERAL SAVINGS AND LOAN BANK OF NEW JERSEY, COASTAL DEVELOPMENTS INC., an Oregon corporation, CONDOSHARE INTERNATIONAL, INC., a Nevada corporation, LITCHFIELD FINANCIAL CORPORATION, a Massachusetts corporation, REGIONS FINANCIAL CORPORATION, formally known as FIRST COMMERCIAL CORPORATION, a Delaware corporation, MERCHANTS MORTGAGE & TRUST CORPORATION, LLC, a Colorado limited liability company, and CHASE MANHATTAN, TRUSTEE OF LITCHFIELD TIMESHARE TRUST1995-1, and no remaining Defendants having appeared in the action and their default having been entered; due notice of which was proved; and no persons objecting; the Court having considered the evidence, and the pleadings and papers on file herein; and it appearing that the allegations of the Verified Complaint To Quiet Title To Real Property are true, and good cause appearing.

NOW, THEREFORE, IT IS HEREBY ORDERED, ADJUDGED AND DECREED as follows:

- 1. The Deeds of Trust described in Exhibit "A" attached hereto and incorporated herein by this reference are declared abandoned, expunged from the record, declared null and void and are of no further effect, and all rights of the beneficiaries thereunder and their successors and/or assigns are hereby terminated effective the date hereof.
- Title to the seventeen (17) separate timeshare intervals referenced in Exhibit 2. "A" attached hereto, is quieted in fee simple absolute, free and clear of all liens and encumbrances, in the name of Plaintiff, namely, KINGSBURY CROSSING OWNERS' ASSOCIATION, a Nevada non-profit corporation, with said parcel of real property, located in Douglas County, state of Nevada, Assessor's Parcel Number 1318-26-101-006, being more particularly described as follows:

AN UNDIVIDED SEVENTEEN THREE THOUSAND TWO HUNDRED and THIRTEENTH INTEREST (17/3213) in that certain lot, piece or parcel of land situate in the County of Douglas, State of Nevada, being a portion of the North ½ of the Northwest ¼ of Section 26, Township 13 North, Range 18 East, M.D.B.&M. described as follows:

Parcel 3, as shown on that amended Parcel Map for John E. Michelsen and Walter Cox recorded February 3, 1981, in Book 281 of Official Records, at page 172, Douglas County, Nevada, as document No. 53178, said map being an amended map of Parcels 3 and 4 as shown on that certain map for John E. Michelsen and Walter Cox, recorded February 10, 1978, in Book 278 of Official Records, at page 591, Douglas County, Nevada, as Document No. 17578.

Also excepting from the real property and reserving to grantor, Its successors and assigns, all those certain easements referred to in paragraphs 2.5, 2.6, and 2.7 of said Declaration of Timeshare Use and amendments thereto together with the right to grant said easements to others.

together with a nonexclusive right to use the common areas as defined in the Declaration.

Subject to all covenants, conditions, restrictions, limitations, easements, rights-of-way of record.

3. Defendants, each of them, and all persons claiming under them, are permanently enjoined from asserting any adverse claim to Plaintiff's free and clear title to the said real property as more particularly described in paragraph 2 above and on Exhibit "A" as of the date hereof.


