FACILITY USE AGREEMENT:

This agreement is made July 14, 2008 between Douglas County Parks and Recreation Department (DCPR) and World Gym, and both parties agree as follows:

- 1. PREMISES.** World Gym allows use to DCPR of its fitness classroom. World Gym is located at 885 Mahogany in Minden, Nevada. DCPR will use the facility according to a pre-determined schedule as determined by Joan Hansen the DCPR contracted Ballet instructor and World Gym. These schedules will be determined three (3) months prior to classes beginning.
- 2. TERM OF AGREEMENT.** The term of the agreement will commence on September 1, 2008, unless termination in accordance with #3, until August 31, 2009.
- 3. TERMINATION.** This agreement may be terminated without cause by either party, provided that a termination shall not be effective until thirty days (30) after a party has served written notice of the termination upon the other party.
- 4. USAGE FEE.** DCPR shall pay World Gym \$225.00 per month. Payment shall be made by the 1st of the month and in conjunction with the County accounts payable calendar. No refund or credit shall be given to the County for any reserved space not used by the County. The parties agree that the amount of the usage fee shall be reviewed annually.
- 5. REPAIR AND MAINTENANCE OF PREMISES.** World Gym will be responsible for routine repair and maintenance to their facility. DCPR will be responsible for routine repair and maintenance and any damage to the premises and its contents caused by the DCPR's use of the premises and any structural damage caused by DCPR.
- 6. UTILITIES.** World Gym shall be responsible for the payment of all utilities.
- 7. MUTUAL COOPERATION.** DCPR agrees to cooperate with World Gym in efforts to operate the premises in an efficient manner in order to reduce cleaning and utility cost. World Gym agrees to operate the premises in a manner, which will not detrimentally affect the County's program or place the program participants in jeopardy.

8. **CONSTRUCTION OF AGREEMENT.** This agreement shall be construed and interpreted according to the laws of the State of Nevada.

10. **INDEMNIFICATION.** Each party agrees to indemnify and save and hold the other party, its agents and employees harmless from any and all claims, causes of action or liability arising from the performance of this agreement by its own agents or employees.
11. **MODIFICATION OF AGREEMENT.** This agreement constitutes the entire contract between the parties and may only be modified by a written amendment signed by the parties.
