ELK POINT COUNTRY CLUB HOMEOWNERS ASSOCIATION, INC. BYLAWS AMENDMENT July 8, 2008

The following Bylaws Amendments are made to the Bylaws of Elk Point Country Club HOA, Inc., recorded as Document 0653319, on August 26, 2005 in the Official Records of Douglas County. The Bylaws of Elk Point Country Club HOA, Inc. recorded as Document 0653319 ("Bylaws") remain in full force and effect, subject to the following Bylaws Amendments:

ARTICLE I of the Bylaws is amended as follows:

<u>Section 3.c)</u> At such meetings, the Unit Owners shall elect the candidates who receive the most votes to the open seats on the Executive Board by using secret written ballots. Eligible candidates are qualified and not suspended Unit Owners as defined by the Articles of Incorporation and the Bylaws. The written ballots will be counted in public by three Unit Owners appointed by the Executive Board.

ARTICLE IV of the Bylaws is amended as follows:

Section 3. The Executive Board can enter into any contract, the performance of which would require up to thirty-six (36) months that does not encumber real property. Unit Owners, by majority vote at a duly call Unit Owners' meeting, voting in person or by proxy, may direct the Board to approve and authorize contracts for longer terms that does not encumber real property.

ARTICLE XV of the Bylaws is amended as follows:

Section 4. The Unit Owner Membership fee for all new Unit Owners shall be \$12,000 which said sum shall accompany all applications for membership. In the event the application is rejected, the membership fee shall be returned to the applicant. All membership fees shall be deposited in the reserve account of the Association. The total membership fees collected in one fiscal year shall be deducted the following year from the contributions that would have been made to the reserve account.

These Bylaws Amendments were adopted on July 5, 2008 by the Unit Owners at the Annual Meeting, by vote in person or by proxy, and are effective as set forth above as of July 5, 2008.
