4 payments or credits on the Judgment.

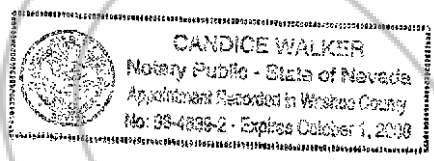
