ORDER AND JUDGMENT

Pursuant to the Stipulation for Judgment on file herein and good cause appearing therefor;

IT IS HEREBY ORDERED that judgment is entered on behalf of the Plaintiff against CASEY WRIGHT, in the principal amount of \$4,027.57, plus prejudgment interest at the rate of 11.581% per annum from December 13, 2005 until entry of judgment, plus attorney's fees of \$750.00, plus costs of suit in the amount of \$176.00, with post-judgment interest accruing on the entire judgment at the legal rate from the date of entry of judgment.


1 IT IS FURTHER ORDERED that Plaintiff shall refrain from execution on the
2 judgment provided CASEY WRIGHT voluntarily pays Plaintiff the sum of \$4,542.44, plus
3 interest and costs, and without attorney's fees, in accordance with the following schedule:

4 Commencing September 20, 2006, \$200.00 per month due on or before the 20th day
5 of each month and continuing thereafter until paid in full.


6 Each payment shall be applied first to any outstanding interest with the remainder applied to
7 the unpaid judgment which contains costs, fees, principal and prejudgment interest.

8 In the event of default by CASEY WRIGHT under the stipulated payment plan,
9 Plaintiff shall be entitled to execute on the full judgment, which includes attorney's fees in the
10 amount of \$750.00, with post-judgment interest accruing on the entire judgment at the legal
11 rate from the date of entry of judgment.


