This matter having come for a prove-up hearing before this Court on Michael Duncan ("Duncan") and Sam Sapper's ("Sapper") (collectively "Plaintiffs") Application for Default Judgment, following this Court's Order dated the 18th day of June 2008 granting Plaintiffs' *Ex Parte* Application for Order Shortening Time, and the Court having entered default against Defendant Karl F. Meyers ("Meyers"). It appears that Meyers is not in the military service of the United States and not an infant or incompetent person, and the Court finding that Meyers was duly and properly served with summons and complaint but failed to defend the claims asserted against him. 2 amount of \$233,216.07, together with interest accruing on the sum certain amount at the judicial
3 rate of 9.25% per annum from May 15, 2008, and until paid in full, which is \$2,718.72 as of June
4 30, 2008;

6 IT IS FURTHER ORDERED that Plaintiffs recover of and from Meyers punitive
7 damages in the amount of \$250,000⁰⁰, with interest accruing thereon at the judicial rate
8 of 9.25% per annum from and after the date hereof;

9 IT IS FURTHER ORDERED that a constructive trust is declared on 564,846 of Meyers'
10 shares of stock in Mineral Energy and Technology Corporation ("METCO"), which shares are
11 ordered to be transferred to Duncan and Sapper to cure the dilution of Duncan and Sapper's
12 shares;

14 IT IS FURTHER ORDERED and declared that 282,423 shares of METCO stock
15 purportedly owned by Meyers but actually held in trust by Meyers are the property of Duncan;

16 IT IS FURTHER ORDERED and declared that 282,423 shares of METCO stock
17 purportedly owned by Meyers but actually held in trust by Meyers are the property of Sapper;

19 IT IS FURTHER ORDERED that Meyers must return stock certificates representing
20 564,846 shares of METCO stock to the offices of Lionel Sawyer & Collins within thirty (30)
